Reliance Power Limited (RPL), is developing Tato-II HYDRO ELECTRIC PROJECT (4X175 MW) on river Siyom in West Siang district of Arunachal Pradesh state, India, on Build Own Operate Transfer (BOOT) basis. RPL will be executing the project through a Special Purpose Vehicle, namely TATO HYDRO POWER PRIVATE LIMITED (THPPL). The SPV has engaged M/s. SNC-LAVALIN Engg. India Pvt. Ltd (SLEI) as the Owner's Consultant for implementing the project.

RPL plans to pre-qualify Companies/unincorporated JVs through International Competitive Bidding in respect of the following works/contracts under the project:

THPPL/Package-3A: EPC Execution of E&M Works covering Turbines, Generators, Auxiliaries, Balance of Plants and a Small Hydro Plant but excluding scope of Package-3B, 3C and 3D (Completion time: 49 months).

THPPL/Package-3B: Design, Manufacture, Supply, Transportation, Storage, Supervision of Installation, Testing and Commissioning of Transformers (Completion time: 33 months).

THPPL/Package-3C: Design, Manufacture, Supply, Transportation, Storage, Supervision of Installation, Testing and Commissioning of GIS and Pothead Yard Equipment (Completion time: 33 months).

THPPL/Package-3D: Design, Manufacture, Supply, Transportation, Storage, Supervision of Installation, Testing and Commissioning of XLPE Cables (Completion time: 33 months).

Qualified bidders would be required to quote separately in sealed envelope for:
